Time Limit for Construction & Automatic Billing for Sewer Services

Billing will begin the earlier of **three (3) months** from the date of issuance of the Permit or, the first day of the month following the date of first inspection.

INSPECTIONS REQUIRED: The District representative must inspect Connections to the District's sewer system and the elder valve/monument installation. Inspection of the installation within the public utility easement / right-of-way is required. Inspections must be called in upon completion of elder valve installation (1st inspect) and monument installation (2nd inspect). Please allow up to 48 hours for inspections to be completed. [See list of requirements on back of this permit.](#)

Failure to complete the terms of this permit will result in Queen Valley Sanitary District completing the requirements that are not met and charging you.

WARNING: Service may not begin until final approval is obtained from the District representative (2nd inspection). District will disconnect service without notice if service begins without inspection and approval from the District.

Documentation Required: County Building Permit, plus site plan, floor plan, & plumbing plan for all classifications except R1 (Single family residential). R1 requires site plan and County Building Permit only. **All site plans, floor plans, etc., must be drawn to scale. Others will not be accepted.**

Locating line/tap: Request at least **two working days** in advance. Location will be made, workdays, 8am to 10am, with stake indicating approximate depth of line or tap. **This permit and staking do not guarantee that a tap/lateral is present.**

Connection: Work must be done in accordance with the Uniform Plumbing Code, District Design Standards, and District Elder Valve Policy. (Elder Valve Parts is waived)
